Application Instructions

New students admitted to the Diploma in Accounting Program may apply for the DAP Entrance Scholarship. Applicants must be registered in DAP courses (full time or part time), for the term in which they were admitted, prior to the DAP Entrance Scholarship application deadline. They must have indicated on their admission application they intend on completing the DAP credential and must have a minimum admission GPA of 75%.

Applications should not be submitted to the DAP office until admission has been granted

All required documents must be submitted to the DAP office by the application deadline (total number of pages included in this application package must be between 8 to 10 pages):

- DAP Entrance Scholarship application form – with all sections completed
- Up-to-date resume (Two pages maximum)
- Two reference letters in support of your community and/or leadership experience on letterhead (contact details required)
